BOARD MEMBERS ELECTIONS

BBB (REGULATION)

CAMPAIGNING AND ELECTIONEERING

In accordance with law, the District may adopt reasonable time, place, and manner restrictions for campaigning and electioneering that takes place during the early voting period and on Election Day.

No District campuses or other District property shall be used to promote a candidate or to promote the candidacy of an incumbent for the Board or for any other political office prior to or following the voting period defined in BBBA(LEGAL). This restriction shall apply as well to the posting of signage on District property.

Campaign literature shall not be distributed at any District or campus function not otherwise designated as a public event, with the exception of an official election-related forum or meet-the-candidate forum that is hosted at a District campus or other facility.

In an effort to maintain the safety of students and staff and to facilitate the flow of traffic around District campuses during the voting period, the District shall only permit electioneering, including the posting of signage during the voting period, outside the 100-foot marker on the side of the property where the entrance to the polling place is located. See BBBA(LEGAL).

All questions regarding the election process shall be referred to the District's office of Accountability and Compliance.

THE FOLLOWING PROVISIONS APPLY UNLESS OTHERWISE SPECIFIED IN A BOARD-ADOPTED NOTICE OF ELECTION, ELECTION ORDER, OR ELECTION SERVICES CONTRACT.

VOTING PRECINCTS

There shall be 11 voting precincts in Board elections, and the polling place in each precinct shall be at a designated location.

Specific Harris County precincts located within the District's boundaries shall be assigned to vote at each of the 11 designated locations.

BBB (REGULATION)

EARLY VOTING

Early voting in Board elections shall be conducted at each of the comprehensive high schools.

ELECTION JUDGES AND WORKERS

The Superintendent shall recommend to the Board qualified personnel to conduct elections for the District. The Board shall approve the appointments of election judge, alternate judge, early voting clerk and deputy early voting clerk.

REQUIREMENTS FOR JUDGES

Election judges must be qualified voters of the District and must reside in the election precinct in which they serve.

REQUIREMENTS FOR WORKERS

The District shall offer appropriate training for judges prior to each District election.

Election workers at election day polling places and early voting polling places must be qualified voters of the District.

QUALIFIED JUDGES AND ALTERNATES

The Administration shall maintain a list of qualified election judges and alternate judges, subject to Board approval.

In the event that a judge or alternate judge is unable to serve, the Administration may contact the County precinct judge to serve in a District election.

In the event that voting precincts are added or existing precincts divided, the Administration may contact the County precinct judge to serve in a District election.

ADDITIONAL WORKERS

In addition to the judge and alternate judge, each precinct shall have the number of additional clerks, usually a maximum of three, necessary for the proper conduct of the election.

PAY FOR ELECTION WORKERS

Election workers shall be paid according to the following scale:

Early Voting Clerk \$13 per hour Deputy Early Voting Clerks \$13 per hour Precinct Judges \$13 per hour Central Counting Station Judge \$13 per hour Alternate Judges \$12 per hour Clerks \$11 per hour

BBB (REGULATION)

On election day, election workers shall be paid for a fifteen hour day at the polls. The election judge shall be paid not more than \$25 for delivery of returns.

The central counting station judge shall receive a minimum compensation of five hours' pay regardless of the amount of time worked.
