On this the 11th day of February 2021, the Board of Trustees of the Pasadena Independent School District convened in a special session with the following members present, to-wit:

and the following absent <u>Nelda Sullivan</u>, Marshall Kendrick constituting a quorum and among other proceedings had by said Board of Trustees was the following:

WHEREAS, Position No. 1, Position No. 2, Position No. 3, and Position No. 4, of the Board of Trustees of this school district will expire on the first Saturday in May 2021, said first Saturday being May 1, 2021; and

WHEREAS, it is necessary for this Board to pass an Order establishing the procedure for filing for and conducting said trustee election.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF PASADENA INDEPENDENT SCHOOL DISTRICT:

That an election be held in said School District on May 1, 2021, for the purpose 1. of electing four (4) members to the Board of Trustees of said School District.

- 2. That all requests by candidates to have their names placed upon the ballot for the above-mentioned election shall be in writing and filed with the District at the office of Associate Superintendent for Accountability and Compliance at 1515 Cherrybrook, Pasadena, Texas, beginning on Wednesday, January 13, 2021, and concluding not later than Friday, February 12, 2021, at 5:00 p.m. Regular office hours for the office of Associate Superintendent for Accountability and Compliance are 8:00 a.m. until 4:30 p.m. The office shall be open from 8:00 a.m. until 5:00 p.m. on the last day to file, February 12, 2021.
- 3. The election shall be conducted by the Harris County Elections Administrator (the "Administrator") pursuant to the terms of a contract for election services and in accordance with the Texas Election Code (the "Election Code") and the Texas Education Code.
- 4. Unless otherwise designated by the Administrator, the boundaries and territory of the respective Harris County election precincts that are wholly or partially within the territorial boundaries of the District are hereby designated as the voting precincts of the District for the Election. The precinct numbers for the District's election precincts shall be the corresponding Harris County precinct number of each precinct. The Administrator is hereby authorized and directed to make such changes in polling locations as may be necessary for the proper conduct of the Election. The Election Day polling places shall be as shown in Exhibit A; provided, however, such precincts and locations may be changed if so directed by the Administrator without further action of the District. Each polling place shall be open from 7:00 A.M. to 7:00 P.M. on Election Day.

The presiding judge and alternate presiding judge for each precinct shall be appointed in accordance with the requirements of the Election Code.

5. Early voting, both by personal appearance and by mail, shall be conducted in accordance with the Election Code. Early voting shall begin on April 19, 2021, and continue through April 27, 2021.

The Administrator is hereby authorized and directed to make such changes in early voting polling locations as may be necessary for the proper conduct of the Election. Early voting by personal appearance shall be conducted at the locations, on the dates and at the times designated in <a href="Exhibit B">Exhibit B</a>; provided, however, such precincts and locations may be changed if so directed by the Administrator without further action of the District. Applications for ballots for voting by mail should be addressed to the early voting clerk.
