Welcome and Announcements - Dr. DeeAnn Powell

Due to a generous donation, every 2021 PISD graduate gets free tuition for 3 years to earn an Associate's Degree or Work Credential from San Jacinto College.

\$147 million Federal Funding earmarked for Pasadena ISD. We need your input as to how to use it to keep students and staff safe and also fill in any learning gaps.

ESSER Overview - Gloria Gallegos

ARP – American Rescue Plan

ESSER (Elementary and Secondary School Emergency Relief Fund) - funding to help reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on students.

How can we use it?

- 20% has to be reserved to address academic and social emotional needs of students – must be evidence based.
- “Other activities that are necessary to maintain the continuity of services and continue to employ existing PISD staff (Slide 12 on PowerPoint). This is where we need your input.
- Feedback from DEC and other groups will be reviewed, needs prioritized, and applications submitted for funding.
- Funds available until 2023 with the possibility of receiving additional funding

Things to consider - Dr. Powell

- Sustainable positions, purchases, and resources after the 3 year period
- Larger retention bonuses next year to retain/recruit quality staff
- Feedback from campuses – software, small group tutors, etc.
- Committed to updating teacher technology - Promethean Boards, projection devices, computer refresh, etc.
- Committed to having full-time counselors at every Elementary campus

- Welcome & Celebrations: Dee Ann Powell (San Jacinto College will provide free tuition to all PISD Graduation Seniors for 3 years. ESSER III- Awarded PISD approximately 147 million dollars)
- ESSER III Overview Information: Gloria Gallegos

POINTS OF DISCUSSION:

1. The intent and purpose of ARP of 2021, ESSER III funding is to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on students.
2. The American Rescue Plan (ARP) Elementary and Secondary School Emergency Relief Fund (ESSER III) has provided PISD \$147,248,350 to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic.
3. Allowable uses of funds:
 - Coordination of preparedness and response efforts.
 - Providing principals and leaders “with the resources necessary to address the needs of their individual schools”.
 - “Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth”.
 - Facilities improvement such as renovations, ventilations, and system upgrades to improve air quality.
 - Developing and implementing preparedness procedures and systems.
 - Training and professional development on sanitations and public health.
 - Purchase of cleaning and sanitizing supplies.
 - Planning for and coordination of technology, meals, and other educational services during long-term closures.
 - Purchase of educational technology, including assistive or adaptive tech/equipment.
 - Mental health services and supports.
 - Planning and implementing summer learning, afterschool, and other programs targeted to high-need students, including virtually.
 - **“Other activities that are necessary to maintain the continuity of services and continue to employ existing PISD staff.”**
