### POINTS OF DISCUSSION:

- 1. The intent and purpose of ARP of 2021, ESSER III funding is to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on students.
- 2. The American Rescue Plan (ARP) Elementary and Secondary School Emergency Relief Fund (ESSER III) has provided PISD \$147,248,350 to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic.
- 3. Allowable uses of funds:
  - Coordination of preparedness and response efforts.
  - Providing principals and leaders "with the resources necessary to address the needs of their individual schools".
  - "Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth".
  - o Facilities improvement such as renovations, ventilations, and system upgrades to improve air quality.
  - $\circ\quad$  Developing and implementing preparedness procedures and systems.
  - o Training and professional development on sanitation and public health.
  - o Purchase cleaning and sanitizing supplies.
  - Planning for and coordinating technology, meals, and other educational services during long-term closures.
  - Purchase of educational technology, including assistive or adaptive tech/equipment.
  - Mental health services and supports.
  - Planning and implementing summer learning, afterschool, and other programs targeted to high-need students, including virtually.
  - "Other activities that are necessary to maintain the continuity of services and continue to employ existing PISD staff."
- 4. Pasadena ISD parents were asked to take a few moments to provide feedback regarding the use of ESSER III funds and the safe reopening of PISD schools.
