- ✓ Applicable to: Vendors requesting to become a Sole Source Vendor
- ✓ <u>Criteria</u>: In order to become a Sole Source Vendor, you must meet the Texas Education Code Statute Number 44.031 (j) Sole Source, as described below.

Selected purchases may be exempt from competitive procurement if they meet the established criteria for a sole source purchase:

- an item for which competition is precluded because of the existence of a patent, copyright, secret process, or monopoly;
- a film, manuscript, or book;
- a utility service, including electricity, gas, or water; and
- a captive replacement part or component for equipment.
- sole source does not apply to mainframe data-processing equipment and peripheral attachments with a single item purchase price in excess of \$15,000.
- ✓ <u>Information must be mailed to:</u> In order to do business with the District as a Sole Source Vendor, PISD must receive a notarized Sole Source Affidavit along with proof of your company being sole source. Please mail this information to:
