

## UNIFORMS

Music organizations represent the school district in many public settings. The physical appearance of these ensembles most often creates the lasting first impression the public has of the organizations. Uniform dress in music organizations creates a positive public image as well as a sense of unity. Students develop a sense of increased pride and positive self-worth when performing in a uniformed organization.

Uniforms are provided for all high school music organizations. Teachers of other music groups are encouraged to develop inexpensive student-provided uniforms for their organizations.

The Fine Arts Department provides a Uniform and Travel Contract (Exhibit 2100) to be used when issuing school-owned uniforms to students. The contract outlines expectations for care of the uniform and speaks to student and parent responsibilities in participation and attendance in music group activities.

Uniforms which are lost or damaged while in the possession of a student are the responsibility of the student and parents. Money to pay for repairs or for uniform replacement will be collected from the student and deposited with the school secretary/bookkeeper into the proper revenue code (see 1065 for code number).
